### 4. Payment

According to the purpose of use, we may require a fee for photographic reproductions. The fee is 3,240 yen for each reproduction of an image (Including consumption tax). (In the case of video usage, the fee is 5,400 yen per image.)This does not include bank charges. You will also be responsible for the transfer fee charged by the bank.

Please be prepared to remit:

Image use fees(Above reference) + Bank fees in Japan (4,000 yen) + remittance fees in your country (please check with your bank for details)

- Do not duplicate without permission and do not use for other uses.
- Permission should also be applied in case of republication.
- In the case of product production, separate procedures are necessary.
